Commemorative Medals – Members were uncertain as to whether Commemorative Medals were to be ordered, the Clerk would be asked to provide an update at the next meeting.

172 DECLARATIONS OF INTEREST

173 ISSUES/QUESTIONS – GENERAL PUBLIC

Representatives from local residents of The Green were in attendance to raise concerns regarding a recent planning application. It was noted that Phase 2 of development at the site was set to commence and concerns were raised in relation to increased levels of traffic and a lack of parking in the area. The application was for a change of use at no.23 The Green from a non residential institution to offices and aromatherapy rooms. It was agreed that a letter should be sent from the Parish to the Planning Authority supporting the efforts already made by Councillor Wilson and to request appropriate signage in the area and for consideration to be given to the parking situation. An objection would also be raised on the grounds of highways issues of parking and traffic volume unless a detailed plan were to be produced indicating alleviation of such problems or alternatively of a plan for the area which did not create such issues in the first place.

Members were in agreement that work needed to be undertaken on the village planters and it was agreed that Changing Lives should be approached to see whether they would be willing to work with the Council on the project.
